### 1. ROOM RATES

Room rates quoted are per night and include GST, complimentary continental breakfast and free local telephone calls (does not include calls to Internet Service Providers).

### 2. RESERVATIONS

### 3. CANCELLATIONS

### 4. GROUP BOOKINGS
